## Review Sessions for December 2010 Exam

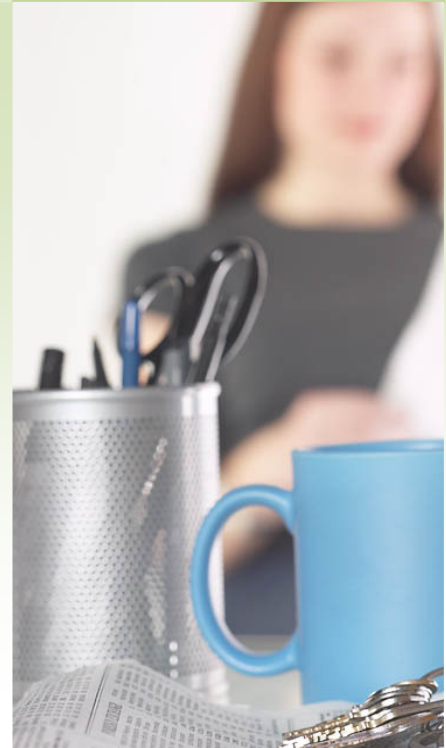
Sydney Chapter is again running a series of Review Sessions for the CISA, CISM and CGEIT to help candidates prepare for the exam. The CISA, CISM & CGEIT exams will be held concurrently on Saturday, 11 December, 2010.

The Review Sessions will be based on the US-supplied CISA, CISM & CGEIT course material with local speaker adaptation and will include a session guide containing copies of all the presentation slides with room for notes, etc.

The sessions are not intended to be training courses. Attendees should have familiarised themselves with the basic concepts before attending the sessions, which are aimed at exploring the CISA, CISM & CGEIT Domains, Tasks and Knowledge Statements respectively.

CISA & CISM sessions will commence at 5.30 pm & CGEIT will commence at 6pm. These sessions are open to exam candidates and general members.
